## **News from Steve Scown**

The Board members talked about **Never Events**. **Never Events** is the name for very serious things that happen when we are working with people we support.



They are so serious that staff need to tell the **Board** about them. The **Board** checks that Dimensions has done the right things to sort out any problems and to learn from what happened.



The **Board** found out about the **Never Events** that had happened recently.



They found out that staff had done a good job of checking what happened. The **Board** found out what staff did to help stop those serious things happening again.



Information about the deaths of people supported by Dimensions



The **Board** looked at the number of deaths of people we support in Dimensions.

Some deaths are expected when people get older, and some people have health problems.



The **Board** wanted to know whether the amount of people who die that are supported by Dimensions were the same as the people in the rest of the country.



The **Board** talked about other health problems of people we support.



The **Board** agreed to find an expert to help us think about the number of people who die that are supported by Dimensions.

This expert will write a report with what they find out every year.




The **Board** looked at last year's **Delivery Plan**. The **Delivery Plan** is a plan that says how Dimensions will do the things it has promised to do.

The **Board** agreed that it is really important that as Dimensions gets bigger, it carries on putting the things it believes at the centre of everything it does.




We want everyone to understand and to feel part of what Dimensions is trying to do.

The Board talked about two new organisations that Dimensions can work with in the future.




They checked to see that we have all the information we need to make decisions about this.
